

**Category VII -Structural Pest
Label Information For Customer Information Document**

COMMON NAME: abamectin (Advance Granular)

STATEMENT OF PRACTICAL TREATMENT: If swallowed contact a Poison Control Center immediately. If on skin or clothing, take of contaminated clothing and wash affected area with soap and water. Contact a physician if irritation persists. If in eyes, rinse slowly and gently with water for 15-20 minutes. Call a physician if irritation persists.

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through skin. Avoid breathing dusts. Avoid contact with skin, eyes, or clothing. Pets may be attracted to this product.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife.

COMMON NAME: abamectin B1 (Avert)

STATEMENT OF PRACTICAL TREATMENT: If in eyes, flush with plenty of water. Seek medical attention if irritation persists. If on skin, wash with soap and warm water. Seek medical attention if irritation persists. If inhaled, remove patient to fresh air. Seek medical attention. If swallowed, contact a poison control center or physician immediately.

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes or clothing.

ENVIRONMENTAL HAZARDS: This pesticide is extremely toxic to fish and wildlife.

COMMON NAME: acephate (Orthene)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, get medical attention immediately. In case of eye contact, immediately flush eyes with fresh water for 15 minutes. Get medical attention if irritation persists.

PRECAUTIONARY STATEMENT: Harmful if swallowed. Avoid contact wit eyes, skin and clothing.

POST APPLICATION INFORMATION: Do not replace the food packages until the surface has dried. Replace shelving paper. Dishes and food handling utensils should be thoroughly washed in soap and water if exposed to contamination by the application of this product. Do not allow children or pets to contact treated surfaces until spray has dried.

COMMON NAME: allethrin (Allethrin)

PRECAUTIONARY STATEMENT: Harmful if swallowed, inhaled or absorbed through the skin. avoid breathing vapors or spray mist and provide adequate ventilation of area being treated. Contact with the eyes, skin or clothing should be avoided. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife.

POST APPLICATION INFORMATION: Do not allow children or pets to contact treated surfaces until spray has dried. In the home, all food processing surfaces, dishes and utensils should be covered during treatment, or thoroughly washed before use.

COMMON NAME: aluminum phosphide (Phostoxin)

STATEMENT OF PRACTICAL TREATMENT: If swallowed induce vomiting by touching back of throat with finger or blunt object. Call physician immediately. If inhaled remove victim to open air and remove contaminated clothing. Keep victim warm. Call physician immediately.

PRECAUTIONARY STATEMENT: Releases hydrogen phosphide (phosphine) gas when moist. Poisonous if inhaled or swallowed. Do not get in eyes or on skin or on clothing.

COMMON NAME: amorphous silica gel, ammonium fluosilicate (Dri-Die)

STATEMENT OF PRACTICAL TREATMENT: If swallowed contact a physician or Poison Control Center immediately. If inhaled remove affected person to fresh air. Apply artificial respiration if indicated. If in eyes or on skin flush with plenty of water. Contact a physician if irritation persists.

PRECAUTIONARY STATEMENT: Avoid inhalation of dust.

COMMON NAME: 4-aminopyridine (Avitrol)

STATEMENT OF PRACTICAL TREATMENT: If swallowed contact your Poison Control Center, hospital or physician immediately. If in eyes: flush with plenty of water. Get medical attention if irritation persists. If on skin: Wash thoroughly with soap and water.

PRECAUTIONARY STATEMENT: Poisonous if swallowed. Harmful if absorbed through skin. May cause eye irritation.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to birds and fish. Wildlife feeding on treated bait may be killed.

COMMON NAME: Bacillus thuringiensis (Teknar)

PRECAUTIONARY STATEMENT: Avoid inhalation or contact with eyes or open wounds.

COMMON NAME: bendiocarb (Ficam)

STATEMENT OF PRACTICAL TREATMENT: If swallowed get medical attention. If inhaled keep patient strictly at rest and transfer to hospital immediately to get medical attention. If on skin wash with soap and warm water. If in eyes rinse thoroughly with clean water .

PRECAUTIONARY STATEMENT: Harmful or fatal if swallowed. May be absorbed through the skin. Avoid contact with eyes, skin and clothing. If contact occurs, wash skin and clothing immediately with soap and warm water. Avoid breathing and working in spray mist or dust.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds, and other wildlife. Birds feeding on treated areas may be killed. This product is highly toxic to bees exposed to direct treatment or to residues on plants.

POST APPLICATION INFORMATION: Do not permit children or pets to contact treated surfaces until spray has dried completely.

COMMON NAME: bifenthrin (Talstar)

STATEMENT OF PRACTICAL TREATMENT: If on skin: Wash with plenty of soap and water. Get medical attention if irritation occurs and persists.

PRECAUTIONARY STATEMENT: Harmful if absorbed through skin. Avoid contact with skin, eyes or clothing.

ENVIRONMENTAL HAZARDS: This pesticide is extremely toxic to fish and aquatic invertebrates.

COMMON NAME: boric acid (Pro! Roach Kill)

PRECAUTIONARY STATEMENT: Harmful if swallowed.

COMMON NAME: boric acid (Pro-Joe Ant Gel/Roach Gel)

STATEMENT OF PRACTICAL TREATMENT: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. If on skin or clothing, remove contaminated clothing and rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. If swallowed, call a poison control center or doctor immediately for treatment advice.

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through the skin. Causes eye irritation. Avoid contact with skin, eyes or clothing.

COMMON NAME: brodifacoum (Talon)

STATEMENT OF PRACTICAL TREATMENT: If bait is eaten by humans, call a physician at once. For 24-hour emergency assistance call ICI Americas, Inc. 302/575-3000. If bait is eaten by animals or pets, call the National Animal Poison Control Center 217/333-3611 or ICI Americas, Inc. 302/575-3000 for 24 - hour emergency assistance.

PRECAUTIONARY STATEMENT: May be harmful or fatal if swallowed. Keep away from humans, domestic animals, and pets.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds and wildlife. This product can pose a secondary hazard to birds of prey and mammals.

COMMON NAME: brodifacoum (Weather Blok)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a poison control center or doctor immediately for treatment advice.

PRECAUTIONARY STATEMENT: May be harmful or fatal if swallowed. Keep away from humans, domestic animals and pets. If bait is eaten by pets, call a veterinarian immediately.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds and wildlife. This product can pose a secondary hazard to birds of prey and mammals.

COMMON NAME: bromadiolone (Contrac, Maki)

STATEMENT OF PRACTICAL TREATMENT: May be harmful or fatal if swallowed or absorbed through the skin. Do not get in eyes, on skin, or on clothing. If swallowed, call a physician at once.

PRECAUTIONARY STATEMENT: Keep away from humans, domestic animals and pets. May be harmful or fatal if swallowed or absorbed through the skin because this material may reduce the clotting ability of the blood and cause bleeding. Do not get in eyes, on skin, or on clothing. If swallowed, call a physician at once.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife.

COMMON NAME: bromethalin (Vengeance)

PRECAUTIONARY STATEMENT: May be harmful or fatal if swallowed. Causes eye irritation. Avoid contact with skin, eyes, or clothing. In case of accidental contact, flush eyes or skin with water and wash contaminated clothing. Seek medical attention immediately if ingested or if breathing difficulty occurs or irritation persists.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds and other wildlife.

COMMON NAME: calcium cyanide (A-Dust)

STATEMENT OF PRACTICAL TREATMENT: State treatment immediately. Call a physician immediately. Carry patient to fresh air. Have him lie down. Remove contaminated clothing but keep patient warm. If inhaled, break an amyl nitrite pearl in a cloth and hold lightly under nose for 15 seconds. Repeat 5 times at about 15-second intervals. Use artificial respiration if breathing has stopped. If swallowed, break an amyl nitrite pearl in cloth and hold lightly under nose for 15 seconds. If patient is conscious or when consciousness returns, give 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention. Repeat inhalation of amyl nitrite 5 times at about 15-second intervals. Use artificial respiration if breathing has stopped. NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON.

PRECAUTIONARY STATEMENT: Poisonous if swallowed. Do not breathe gas or dust. Do not take internally. Do not get in eyes or on skin.

COMMON NAME: carbaryl (Sevin)

STATEMENT OF PRACTICAL TREATMENT: Contact a physician immediately in all cases of suspected poisoning. Transport to a physician or hospital immediately. If in eyes, flush eyes with plenty of water. Get medical attention if irritation persists. If on skin, wash thoroughly with soap and water. If inhaled, move from contaminated atmosphere and call a physician.

PRECAUTIONARY STATEMENT: May be harmful if swallowed. Avoid breathing spray. Do not take internally. Avoid contact with skin, eyes or clothing. Do not enter treated areas without protective clothing until sprays have dried.

ENVIRONMENTAL HAZARDS: This product is extremely toxic to aquatic and estuarine invertebrates. This product is highly toxic to bees exposed to direct treatment or residues.

COMMON NAME: chlorfenapyr (Phantom)

STATEMENT OF PRACTICAL TREATMENT: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. If on skin or clothing, remove contaminated clothing and rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. If swallowed, call a poison control center or doctor immediately for treatment advice. If inhaled, move person to fresh air. Call a poison control center or doctor for further treatment advice.

PRECAUTIONARY STATEMENT: Harmful if swallowed, inhaled or absorbed through the skin. Causes moderate eye irritation. Do not get in eyes, on skin, or on clothing. Avoid breathing vapors or spray mist.

ENVIRONMENTAL HAZARDS: This product is toxic to aquatic organisms, birds and wildlife. This chemical has properties and characteristics associated with chemicals detected in groundwater. The use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in groundwater contamination. Application around a well or cistern may cause contamination of drinking water or groundwater.

POST APPLICATION INFORMATION: Indoor Treatment: Remove all food and cooking utensils. Cover all food handling surfaces and wash thoroughly after treatment. Do not allow contact to treated areas until spray has dried. Remove pets and cover or remove fish bowls prior to application.

COMMON NAME: chlorpyrifos (Tenure)

STATEMENT OF PRACTICAL TREATMENT: If swallowed: Call a physician or Poison Control Center immediately. Do not induce vomiting. If on skin: Immediately wash plenty of soap and water. Get medical attention. If in eyes: Flush with plenty of water for 15 minutes. Get medical attention. If inhaled: Remove to fresh air if symptoms of cholinesterase inhibition appear and get medical attention immediately.

PRECAUTIONARY STATEMENT: May be fatal if swallowed. Excessive absorption through skin may be fatal. Causes substantial but temporary eye injury. May cause skin irritation. Do not get in eyes, on skin or clothing. Avoid breathing vapors and spray mist.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to birds and wildlife, and extremely toxic to fish and aquatic organisms.

COMMON NAME: cholecalciferol (Quintox)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Avoid use of all oils.

PRECAUTIONARY STATEMENT: Keep away from humans, domestic animals and pets.

COMMON NAME: chlorophacinone (Rozol)

STATEMENT OF PRACTICAL TREATMENT: Do not get in eyes, on skin, or on clothing. If swallowed call a physician immediately.

PRECAUTIONARY STATEMENT: Keep away from humans, domestic animals and pets. May be harmful or fatal if swallowed or absorbed through the skin because this material may reduce the clotting ability of the blood and cause bleeding.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife.

COMMON NAME: chlorpyrifos (Dursban, Empire 20, Equity)

STATEMENT OF PRACTICAL TREATMENT: If swallowed call a physician or Poison Control Center immediately. If on skin wash with plenty of soap and water. Get medical attention. If inhaled remove to fresh air.

PRECAUTIONARY STATEMENT: Harmful if swallowed, harmful if absorbed through skin, causes substantial but temporary eye injury.

ENVIRONMENTAL HAZARDS: This pesticide toxic to birds and other wildlife and extremely toxic to fish and aquatic organisms.

POST APPLICATION INFORMATION: (General Information) Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. Remove pets and cover fish bowls (tanks) before spraying. Do not allow adults, children or pets on treated areas until spray has dried. Do not allow livestock to graze in treated areas. Do not feed treated grass cuttings (hay) or seed screenings to livestock, nor use hay for livestock bedding.

POST APPLICATION INFORMATION: (Indoor Broadcast Sprays) Other than the applicator, treated areas should be vacated during application.

POST APPLICATION INFORMATION: (Wood-Infesting Insects Control) Do not permit humans or pets to contact treated surfaces until spray has dried. Following treatment thoroughly ventilate treated areas before they are reoccupied. Buildings (office building, for example) with restricted air flow should have the ventilation system adjusted to include outside air for 24 hours.

COMMON NAME: cyfluthrin (Optem)

STATEMENT OF PRACTICAL TREATMENT: If swallowed: Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger or blunt object. Do not induce vomiting or give anything by mouth to an unconscious person. If on Skin: Wash with plenty of soap and water. Get medical attention if irritation persists. If in eyes: Wash thoroughly with water for at least 15 minutes. Call a physician if symptoms occur.

PRECAUTIONARY STATEMENT: Harmful if absorbed through skin. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Do not allow children or pets to contact treated surfaces until spray has dried. Cover fish tanks prior to application. Do not apply this product in patient rooms while occupied or in any rooms while occupied by the elderly or infirm. Do not apply to classrooms when in use.

ENVIRONMENTAL HAZARDS: This product is extremely toxic to fish and aquatic invertebrates. Remove from premises or tightly cover fish tanks and disconnect aerators when applying indoors where such containers are present.

COMMON NAME: cyfluthrin (Tempo)

STATEMENT OF PRACTICAL TREATMENT: If eyes are contaminated, flush eyes with plenty of water. Call a physician if irritation persists. If swallowed, call a physician or Poison Control Center. If on skin, wash skin immediately with soap and warm water. Get medical attention. If inhaled, remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth to mouth. Get medical attention.

PRECAUTIONARY STATEMENT: Causes moderate eye irritation. Harmful if swallowed, inhaled or absorbed through the skin. Do not get in eyes or on clothing. Avoid contact with skin, eyes, or clothing. Avoid breathing

dust.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish. Remove from premises or tightly cover fish tanks when applying indoors where such containers are present.

COMMON NAME: cypermethrin (Cynoff, Demon, Prevail)

STATEMENT OF PRACTICAL TREATMENT: If in eyes flush with plenty of water. Get medical attention if irritation persists. If on skin, wash with plenty of soap and water. If swallowed, contact a physician or Poison Control Center.

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through skin. Causes eye irritation. Do not get in eyes, or on skin or on clothing.

ENVIRONMENTAL HAZARDS: This product is extremely toxic to fish.

COMMON NAME: deltamethrin (Suspend SC)

STATEMENT OF PRACTICAL TREATMENT: If inhaled: Remove victim to fresh air. If not breathing, give artificial respiration preferably mouth to mouth. Get medical attention.

PRECAUTIONARY STATEMENT: Keep Out of Reach of Children. Harmful if inhaled. Avoid breathing vapor or spray mist. Remove contaminated clothing and wash before reuse.

ENVIRONMENTAL HAZARDS: This product is extremely toxic to fresh water and estuarine fish and invertebrates.

COMMON NAME: deltamethrin (DeltaDust, DeltaGard)

STATEMENT OF PRACTICAL TREATMENT: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. If on skin or clothing, remove contaminated clothing and rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. If swallowed, call a poison control center or doctor immediately for treatment advice. If inhaled, move person to fresh air. Call a poison control center or doctor for further treatment advice.

PRECAUTIONARY STATEMENT: Harmful if swallowed. Causes moderate eye irritation. Avoid contact with eyes or clothing.

ENVIRONMENTAL HAZARDS: This product is extremely toxic to fish and aquatic invertebrates.

COMMON NAME: diazinon (Diazinon)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove victim to fresh air. Apply artificial respiration if indicated. If on skin, remove contaminated clothing and wash affected areas with soap and water. If in eyes, flush eyes with plenty of water. Call a physician immediately.

PRECAUTIONARY STATEMENT: May be fatal if swallowed. May be absorbed through the skin. Do not breathe spray mist. Do not get in eyes, on skin or on clothing. Keep children and pets off treated areas until this material is washed into the soil and grass is dry .

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds, and other wildlife. Birds and other wildlife feeding on treated areas may be killed. This product is highly toxic to bees exposed to direct treatment or residues remaining on crops.

COMMON NAME: dichlorvos (DDVP, Vapo)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove victim to fresh air. Apply artificial respiration if indicated. If on skin, remove contaminated clothing and wash affected areas with soap and water. If in eyes, flush eyes with plenty of water. Call a physician.

PRECAUTIONARY STATEMENT: Poisonous if swallowed, inhaled or absorbed through the skin or eyes. Do not get on skin or in eyes. Do not breathe fumes.

POST APPLICATION INFORMATION: Food handling equipment, dishes, should be washed after treatment. Remove all pets, cover fish tanks or remove. Cover house plants within 8 feet of point of release with newspaper to prevent possible burning of tender plants. Open doors and windows and allow to be ventilated for 1 hour before occupying. Do not allow children to lie or sleep in treatment areas until at least 6 hours following treatment.

COMMON NAME: difethialone (Generation Mini Blocks)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin with plenty of cool water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

PRECAUTIONARY STATEMENT: Keep away from children, domestic animals and pets. May be harmful or fatal if swallowed or absorbed through the skin, because it may reduce the clotting ability of blood and cause bleeding. Do not get in eyes, on skin or on clothing.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife.

COMMON NAME: dioxathion (Deltic)

STATEMENT OF PRACTICAL TREATMENT: Remove patient from Deltic exposure. Never give anything to an unconscious or convulsing person. If swallowed, call a physician or Poison Control Center immediately. If in eyes, flush eyes with plenty of water while holding the eyelids open. Get medical attention. If inhaled, move person to an uncontaminated area. If signs of poisoning appear get medical attention. If on skin, remove contaminated clothing and immediately wash skin with soap and water. Call a physician immediately in all cases of suspected poisoning.

PRECAUTIONARY STATEMENT: May be fatal if swallowed, absorbed through skin or inhaled. Do not breathe vapors or spray mist. May cause eye irritation.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds and other wildlife.

POST APPLICATION INFORMATION: Keep children and pets off treated areas until completely dry.

COMMON NAME: diphacinone (P.C.Q., Promar, Rodent Cake)

STATEMENT OF PRACTICAL TREATMENT: If swallowed by humans, pets, wildlife or domestic animals, this material may reduce the clotting ability of the blood and cause bleeding. In case of ingestion, call a physician.

PRECAUTIONARY STATEMENT: Treated baits must be placed in locations not accessible to children, pets, wildlife and domestic animals, or in tamper proof bait stations.

COMMON NAME: diphacinone (Ditrac)

STATEMENT OF PRACTICAL TREATMENT: If on skin or clothing, remove contaminated clothing and rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. If swallowed, call a poison control center or doctor immediately for treatment advice.

PRECAUTIONARY STATEMENT: May be fatal if swallowed or absorbed through the skin. Do not get in eyes, on skin, or on clothing.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds and other wildlife.

COMMON NAME: disodium octaborate tetrahydrate (Bora-Care, Tim-bor)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, give 1 or 2 glasses of water and seek medical attention or contact a Poison Control Center. If in eyes, flush with plenty of water. Get medical attention if irritation persists. If on skin, remove contaminated clothing and wash skin with water. If inhaled, remove victim to fresh air.

ENVIRONMENTAL HAZARDS: Tim-bor or Tim-bor solutions carelessly spilled or applied to cropland or growing plants, including trees and shrubs. May kill or seriously retard plant growth.

COMMON NAME: endrin (Perch Solution)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician immediately. If on skin, remove by washing with soap and water. Get medical attention. If in eyes, flush the eyes with clean water for 10 minutes. Get medical attention. If inhaled, remove victim to fresh air. Transport immediately to emergency treatment facility.

PRECAUTIONARY STATEMENT: Poisonous if swallowed, inhaled or absorbed through the skin. Do not breathe spray mist. Do not get in eyes, on skin or on clothing.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish and wildlife.

COMMON NAME: fenoxycarb (Torus 2E)

STATEMENT OF PRACTICAL TREATMENT: If swallowed call a physician or poison control center for advise. Get medical attention. If in eyes flush eyes immediately with plenty of water and get medical attention.

PRECAUTIONARY STATEMENT: Do not get in eyes or on clothing. Harmful if inhaled or absorbed through skin. Avoid contact with skin. Avoid breathing spray mist.

POST APPLICATION INFORMATION: Dishes and food handling utensils should be thoroughly washed in soap and water if exposed to contamination by the application of the product. Do not allow children or pets to contact treated surfaces until spray has dried.

COMMON NAME: fenthion (Baytex)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, professional medical assistance should be secured immediately. Wash thoroughly with soap and water after handling. Wash clothing with soap and hot water before reuse.

PRECAUTIONARY STATEMENT: Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes and clothing. Keep gel away from foods and food contact surfaces. Product may stain textiles and clothing.

COMMON NAME: fipronil (Termidor SC)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a poison control center or doctor immediately for treatment advice. If on skin or clothing, take of contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. If inhaled, move person to fresh air. Drink 1 or 2 glasses of water and induce vomiting by touching the back of the throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

PRECAUTIONARY STATEMENT: Avoid breathing spray mist. Harmful if absorbed through skin. Avoid contact with eyes, skin or clothing. Wash exposed skin with soap and water after handling and before eating.

ENVIRONMENTAL HAZARDS: This product is highly toxic to fish.

COMMON NAME: hexaflumuron (Recruit)

PRECAUTIONARY STATEMENT: Keep Out of Reach of Children.

COMMON NAME: hydramethylnon (Maxforce, Siege)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, drink two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention.

PRECAUTIONARY STATEMENT: May be harmful if swallowed. Avoid skin contact. Wear rubber gloves during application. Wash thoroughly after handling.

COMMON NAME: s-hydroprone (Gentrol IGR)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, contact a poison control center or doctor immediately. If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes and continue rinsing eye. If on skin or clothing, remove contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. If inhaled, move person to fresh air.

PRECAUTIONARY STATEMENT: Poisonous if swallowed, inhaled, or absorbed through the skin. Causes eye irritation. Do not get in eyes or on skin. Do not breathe fumes.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish and wildlife.

COMMON NAME: imidacloprid (Premise 75)

STATEMENT OF PRACTICAL TREATMENT: If swallowed: Call a physician or Poison Control Center. Drink

one or two glasses of water and induce vomiting by touching back of throat with finger, or if available, by administering syrup of ipecac. If vomiting does not occur within 20 minutes, repeat the dose once. Do not induce vomiting or give anything by mouth to an unconscious person. If on skin: Wash thoroughly with soap and water. Get medical attention if irritation occurs. if in eyes: Hold eyelids open and flush with plenty of water.

ENVIRONMENTAL HAZARDS: This product is highly toxic to aquatic invertebrates.

COMMON NAME: lambda-cyhalothrin (Commodore WP, Demand CS)

STATEMENT OF PRACTICAL TREATMENT: If swallowed: Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. If in eyes: Wash with plenty of water. Get medical attention if irritation persists. If on skin: Wash with plenty of soap and water. Get medical attention if irritation persists. If inhaled: Remove victim to fresh air. If not breathing, give artificial respiration, preferably by mouth-to-mouth.

PRECAUTIONARY STATEMENT: May be fatal if swallowed. Harmful if absorbed through skin or inhaled. Causes eye irritation May cause allergic skin reaction. Do not get in eyes, on skin or clothing. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling.

ENVIRONMENTAL HAZARDS: This product is extremely toxic to fish.

COMMON NAME: linalool (Demize)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center. If in eyes, hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Call a physician. If on skin, wash with plenty of soap and water. Get medical attention if irritation persists.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish and wildlife.

COMMON NAME: lindane (Lindane No.20)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove person to fresh air. Apply respiration, if indicated. If on skin, wash area immediately with soap and warm water. If in eyes, flush with plenty of water and get prompt medical attention.

PRECAUTIONARY STATEMENT: May be absorbed through skin, harmful if swallowed. Avoid inhalation of spray mist. Avoid skin contact. In case of contact, wash immediately with soap and water.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds, and other wildlife. Birds and other wildlife feeding in treated areas may be killed.

COMMON NAME: magnesium phosphide (Fumi-Cel)

STATEMENT OF PRACTICAL TREATMENT: Upon exposure to atmospheric moisture FUMI-CEL releases hydrogen phosphide (phosphine). If swallowed, induce vomiting by touching back of the patient's throat with a blunt object such as the finger. If inhaled, remove victim to open air. Make him lie down and keep him warm. Call a physician immediately. If on skin, wash affected area with soap and water. If in eyes, flush thoroughly with water.

COMMON NAME: methomyl (Flytek)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention. If on skin, remove contaminated clothing and wash affected areas with soap and water. If in eyes, flush eyes with plenty of water. Call a physician immediately.

PRECAUTIONARY STATEMENT: Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing dust. Avoid contact with skin, eyes or clothing.

ENVIRONMENTAL HAZARDS: Exposed surfaces treated with this bait are hazardous to birds and other wildlife.

COMMON NAME: methoprene (Precor)

STATEMENT OF PRACTICAL TREATMENT: In case of contact, immediately flush skin or eyes with plenty of water. Get medical attention if irritation persists.

COMMON NAME: methyl bromide (Meth-O-Gas)

STATEMENT OF PRACTICAL TREATMENT: If inhaled remove victim to fresh air immediately. Keep victim lying down and warm. Give artificial respiration if breathing has stopped. Call a physician at once. If on skin, remove all contaminated clothing and shoes at once. Wash exposed areas thoroughly with soap and water. If a rash or blisters develop get medical attention. If it gets into eyes, flush eyes with running water for at least 15 minutes. Get medical attention promptly.

STATEMENT OF PRACTICAL TREATMENT: If in eye, flush eyes with water for 15 minutes. Call a physician. If swallowed, do not induce vomiting. Call a physician. If on skin, remove contaminated clothing. Wash with plenty of soap and water. Get medical attention if irritation persists. In case of accidental exposure to pesticide spray or dust, wash the skin thoroughly with soap and water. Remove contaminated clothing and wash before reuse. If in eyes, flush with plenty of water. If inhaled, go to an area where the pesticide has not been applied. Get medical attention if needed.

ENVIRONMENTAL HAZARDS: This product is extremely toxic to fish.

ENVIRONMENTAL HAZARDS: This product is highly toxic to bees.

POST APPLICATION INFORMATION: Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. POST APPLICATION INFORMATION: Keep children and pets off treated areas until surfaces are dry.

COMMON NAME: pyrethrins (Kicker)

STATEMENT OF PRACTICAL TREATMENT: If swallowed: Contact a physician or Poison Control Center immediately. Do not induce vomiting unless directed by a physician. If in eyes: Flush with water for approximately 15 minutes. Contact a physician if irritation persists. If on skin: Remove contaminated clothing. Wash skin with plenty of soap and water. Contact a physician if irritation persists. If inhaled: Remove victim to fresh air. Apply artificial respiration if indicated.

PRECAUTIONARY STATEMENT: Harmful if swallowed. Do not get in eyes. Do not breathe spray mist. The area being treated must be vacated by unprotected persons. Do not enter treated areas without protective clothing until sprays have dried.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, shrimp, crab and other aquatic organisms.

COMMON NAME: pyrethrins, piperonyl butoxide, MGK 264 (Pyrocide)

STATEMENT OF PRACTICAL TREATMENT: If on skin or clothing, remove contaminated clothing and rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. If swallowed, call a poison control center or doctor immediately for treatment advice. If inhaled, move person to fresh air. Call a poison control center or doctor for further treatment advice.

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through the skin. Avoid breathing vapor. Avoid contact with skin or clothing. Do not contaminate water, food or foodstuffs.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds and other wildlife.

POST APPLICATION INFORMATION: Do not remain in treated area and ventilate the area after treatment is completed. Remove all pets and birds. Remove or cover and turn off air pumps to aquariums, if conditions permit.

COMMON NAME: pyrethrins, piperonyl butoxide, amorphous silica gel (Drione)

PRECAUTIONARY STATEMENT: Avoid inhalation.

ENVIRONMENTAL HAZARDS: This product is toxic to fish.

COMMON NAME: pyrethrins and piperonyl butoxide (Pyrenone)

STATEMENT OF PRACTICAL TREATMENT: If swallowed contact a physician or Poison Control Center.

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes.

ENVIRONMENTAL HAZARDS: This product is toxic to fish.

COMMON NAME: pyriproxyfen (Archer)

STATEMENT OF PRACTICAL TREATMENT: If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. If on skin or clothing, remove contaminated clothing and rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. If swallowed, call a poison control center or doctor immediately for treatment advice. If inhaled, move person to fresh air. Call a poison control center or doctor for further treatment advice.

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through the skin. Do not breathe vapor or

spray mist. Avoid contact with skin or eyes. In case of contact flush with plenty of water. Avoid contamination of food or feedstuffs.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and aquatic invertebrates.

POST APPLICATION INFORMATION: Do not allow adults, children or pets to contact treated surfaces until area treated has completely dried.

COMMON NAME: resmethrin (Resmethrin)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center. If in eyes, flush with plenty of water. Get medical attention if irritation persists. If on skin, wash with soap and plenty of water. Get medical attention if irritation persists.

PRECAUTIONARY STATEMENT: Harmful if swallowed. Avoid breathing vapor or spray mist. Avoid contact with skin, eyes or clothing.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and birds.

COMMON NAME: sodium fluoride (Certox)

STATEMENT OF PRACTICAL TREATMENT: Call a physician at once!

PRECAUTIONARY STATEMENT: May be fatal if swallowed. Do not breathe dust.

COMMON NAME: s-hydroprone (Gentrol IGR)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, contact a poison control center or doctor immediately. If in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes and continue rinsing eye. If on skin or clothing, remove contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. If inhaled, move person to fresh air.

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through the skin. Causes moderate eye irritation. Avoid contact with eyes, skin, or clothing.

POST APPLICATION INFORMATION: When treating around air ducts, turn off ventilation systems. Allow treatment to dry prior to turning ventilation system back on. If breathing stops, start mouth-to-mouth resuscitation immediately. If heart beat stops, start cardiopulmonary resuscitation immediately.

COMMON NAME: tetramethrin (Apollo)

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through skin. Avoid breathing vapors. Avoid contact, immediately wash skin with plenty of water. Do not use in commercial food processing, preparation, storage or serving areas. In the home all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Cover exposed food. Remove pets, birds and cover fish aquariums before spraying.

COMMON NAME: tralomethrin (Saga WP)

STATEMENT OF PRACTICAL TREATMENT: If swallowed: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching the back of throat with a finger. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person. If on skin: Remove contaminated clothing and wash affected areas with soap and water. Get medical attention. If inhaled: Remove victim to fresh air. Apply artificial respiration if indicated. Get medical attention. If in eyes: Flush eyes with plenty of water. Call a physician if irritation persists.

PRECAUTIONARY STATEMENT: May be fatal if swallowed. Harmful if absorbed through the skin or inhaled. Causes eye irritation. Avoid breathing dust or spray mist. Avoid contact with skin, eyes or clothing.

ENVIRONMENTAL HAZARDS: This pesticide is extremely toxic to fish and other aquatic organisms, including crab and shrimp.

COMMON NAME: warfarin (Liqua-Tox)

PRECAUTIONARY STATEMENT: Keep away from humans, domestic animals, and pets. If swallowed by humans, domestic animals or pets, this material may reduce the clotting ability of the blood and cause bleeding. In case of ingestion, call a physician.

COMMON NAME: zinc phosphide (Gopha Rid, ZP Tracking Powder)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center. If on skin or in eyes, flush with plenty of water.

PRECAUTIONARY STATEMENT: Keep away from humans, domestic animals, and pets. May be fatal or harmful if swallowed or inhaled. Avoid skin contact. Do not breathe dust. Avoid contamination of feed or foodstuffs.

ENVIRONMENTAL HAZARDS: This product is toxic to birds and other wildlife.

WHITMIRE (by PT Number)

COMMON NAME: resmethrin (PT 110)

STATEMENT OF PRACTICAL TREATMENT: If in eyes, immediately flush eyes with plenty of water. Get medical attention if irritation persists. If swallowed, call a physician or Poison Control Center immediately. If on skin, remove contaminated clothing and wash affected areas with soap and water. If inhaled, remove patient to fresh air. Apply artificial respiration if indicated.

PRECAUTIONARY STATEMENT: Avoid breathing of spray mist. Avoid contact with eyes, skin or clothing. In case of contact flush eyes or skin with water.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish and birds.

POST APPLICATION INFORMATION: All food contact surfaces and cooking utensils should be covered during treatment or thoroughly cleaned before using. Remove pets and birds and cover aquariums before using.

COMMON NAME: pyrethrins, piperonyl butoxide, silica gel (PT 230)

STATEMENT OF PRACTICAL TREATMENT: If in eyes, flush eyes with plenty of water. Get medical attention. If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove victim to fresh air. Apply artificial respiration if indicated. If on skin, remove contaminated clothing and wash affected areas with soap and water.

PRECAUTIONARY STATEMENT: Causes eye damage. Do not get in eyes or on clothing.

COMMON NAME: boric acid (PT 240)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove victim to fresh air. Apply artificial respiration if indicated. If on skin, remove contaminated clothing and wash affected areas with soap and water. If in eyes, flush eyes with plenty of water. Get medical attention immediately.

PRECAUTIONARY STATEMENT: May cause eye damage. Harmful if swallowed or inhaled or absorbed through skin. Do not get in eyes or on clothing.

COMMON NAME: propoxur (PT 250)

PRECAUTIONARY STATEMENT: May be harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes, or clothing should also be avoided. Should illness occur, get prompt medical aid.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and birds.

COMMON NAME: diazinon (PT 260)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove patient to fresh air. Apply artificial respiration if indicated. If on skin, remove contaminated clothing and wash affected areas with soap and water. If in eyes, flush eyes with plenty of water. Get medical attention immediately.

PRECAUTIONARY STATEMENT: May cause eye irritation. Harmful if swallowed or inhaled. May be absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes, or clothing.

POST APPLICATION INFORMATION: Keep children and pets off treated areas until spray has dried.

COMMON NAME: diazinon (PT 265A)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If on skin, remove contaminated clothing and wash affected areas with soap and water. If on eyes, flush eyes with plenty of water. Get medical attention immediately.

PRECAUTIONARY STATEMENT: May cause eye irritation. Harmful if swallowed or inhaled. May be absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes, or clothing.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds, and other wildlife.

POST APPLICATION INFORMATION: Keep children and pets off treated areas until spray has dried.

COMMON NAME: chlorpyrifos (PT 270)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove patient to fresh air. Get medical attention if poisoning symptoms occur. If on skin, wash skin with soap and water. Get medical attention if irritation persists. If in eyes, flush eyes with plenty of water. Get medical attention if irritation persists.

PRECAUTIONARY STATEMENT: May be harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes, or clothing should also be avoided. Should illness occur, get prompt medical aid.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and birds.

COMMON NAME: acephate (PT 280)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove patient to fresh air. Get medical attention if poisoning symptoms occur. If on skin, wash skin with plenty of soap and water. If in eyes, flush eyes with plenty of water. Get medical attention if irritation persists.

PRECAUTIONARY STATEMENT: Harmful if swallowed or inhaled. May be absorbed through skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes, clothing.

POST APPLICATION INFORMATION: Do not allow children or pets to contact treated surfaces until spray has dried.

COMMON NAME: pyrethrins, piperonyl butoxide, n-octylbicycloheptene dicarboximide (PT 3-6-10)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center immediately. If inhaled, remove patient to fresh air. Get medical attention if poisoning symptoms occur. If on skin, wash skin with plenty of soap and water. If in eyes, flush eyes with plenty of water. Get medical attention if irritation persists.

PRECAUTIONARY STATEMENT: Harmful if swallowed or inhaled. May be absorbed through skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes, clothing.

ENVIRONMENTAL HAZARDS: This product is toxic to fish, birds, and other wildlife.

COMMON NAME: abamectin, avemectin (PT 370)

STATEMENT OF PRACTICAL TREATMENT: If swallowed: Call a physician or Poison Control Center. Give 1 or 2 glasses of water and immediately induce vomiting by gently touching back of throat with finger or administer syrup of ipecac. Do not give anything by mouth to an unconscious person. Get medical attention. If on skin: Remove contaminated clothing and wash affected areas with soap and water. If in eyes: Flush eyes with plenty of water. Call a physician if irritation persists.

COMMON NAME: pyrethrins, piperonyl butoxide (PT 500)

PRECAUTIONARY STATEMENT: Do not remain in treated areas and ventilate the area after treatment is completed. Avoid breathing of vapor. Avoid contact with skin, eyes, or clothing. In case of contact immediately flush eyes or skin with plenty of water. Get medical attention if irritation persists.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and birds.

COMMON NAME: tetrachloroethylene, trichloromonofluoromethane, dichlorodifluoro-methane, petroleum distillate, methylene chloride, pine oil, rotenone, cube resins, pyrethrins (PT 515)

PRECAUTIONARY STATEMENT: Do not remain in treated areas and ventilate the area after treatment is completed. Avoid breathing of vapor.

COMMON NAME: resmethrin (PT 550)

PRECAUTIONARY STATEMENT: Do not remain in treated areas and ventilate the area after treatment is completed. Avoid breathing of vapor. Avoid contact with skin, eyes, or clothing. In case of contact, immediately flush eyes or skin with plenty of water. Get medical attention if irritation persists. Remove all pets and birds. Cover fish tanks or remove before spraying.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and birds.

POST APPLICATION INFORMATION: All food processing surfaces should be covered during treatment or thoroughly cleaned before using.

COMMON NAME: pyrethrins, MGK264 (PT 565)

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact flush eyes or skin with plenty of water. Obtain medical attention if irritation persists. Remove pets and birds, and cover fish aquariums before spraying.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and birds.

POST APPLICATION INFORMATION: After space spraying in meat packing plants, bakeries, and other food processing plants wash with potable water all equipment, benches, shelves, etc. where exposed food will be handled. All food processing surfaces and utensils should be covered during treatment or thoroughly washed before use.

COMMON NAME: pyrethrin, allethrin, piperonyl butoxide, MGK264 (PT 565 Plus)

PRECAUTIONARY STATEMENT: Harmful if swallowed or absorbed through skin. Do not remain in treated area and ventilate the area after treatment is completed. Avoid breathing a vapor. Avoid contact with skin, eyes, or

clothing. Remove all pets and birds. Cover fish tanks or remove before spraying. IN HOSPITALS -Patients should be removed from room prior to treatment.

POST APPLICATION INFORMATION: Ventilate the area after treatment. After space spraying, food contact surfaces and equipment must be washed with an effective cleaning compound followed by a potable water rinse. IN HOSPITALS -Room should be ventilated for two hours after spraying. Do not return patients to room until after ventilation.

COMMON NAME: pyrethrins, piperonyl butoxide (PT 575)

PRECAUTIONARY STATEMENT: Harmful if swallowed. Avoid inhalation of vapor. Avoid contact with skin, eyes, or clothing. Wash contaminated skin promptly with soap and water. Get medical attention if irritation persists. Remove pets, birds, cover fish aquariums before spraying.

POST APPLICATION INFORMATION: All occupants must be removed from house or building before treatment is started and should not re-occupy building for at least one hour.

COMMON NAME: carbaryl, rotenone, pyrethrins, piperonyl butoxide (PT 585)

STATEMENT OF PRACTICAL TREATMENT: If swallowed, call a physician or Poison Control Center. If inhaled, remove patient to fresh. Get medical attention if poisoning symptoms occur. If on skin, wash skin with soap and water. Get medical attention if irritation persists. If in eyes, flush eyes with plenty of water. Get medical attention if irritation persists.

PRECAUTIONARY STATEMENT: Avoid prolonged breathing of spray mist. In case of eye contact, flush eyes with plenty of water. Get medical attention if irritation persists.
